

**Calvert County Mosquito Control
2020**

Request for Exemption from Adult Mosquito Control Services

Individuals residing within a community participating in the Mosquito Control Program may request to have his/her owned or leased real property EXCLUDED from adult mosquito control pesticide applications by truck-mounted ultra-low volume (ULV) sprayers. **Residents may request one of two options:**

1. Exclusion from spraying along the road frontage of the property. Each individual requesting this exclusion must submit a copy of this form to the community representative.
2. Exclusion including a surrounding buffer up to 300 feet on all sides of the property. Those requesting the 300-foot property buffer must submit an exemption request form to the Maryland Department of Agriculture, which will forward the request to Calvert County Mosquito Control. **Calvert County Mosquito Control
Permission to Enter Private Property
for the Suppression of Adult Mosquitoes**

Private property includes, but is not limited to, lawns and driveways. Private driveways will be considered provided there is turnaround space, accessibility and the community representative approves with a map showing the driveway. Private driveways will then be considered for spraying at the discretion of the driver.

The undersigned grants permission to the Board of County Commissioners for Calvert County, Maryland, by and through its Calvert County Mosquito Control Program, to have access and to enter the undersigned's property, as identified in the Community Request for Service form attached hereto and incorporated herein by reference, for the purpose of spraying pursuant to the terms and conditions of the program of mosquito control in the County of Calvert, State of Maryland. This permission may be cancelled at any time by the property owner in writing to the Calvert County Mosquito Control Program. The Calvert County Mosquito Control Program reserves the right to amend and/or deny service. The undersigned agrees to indemnify, defend and hold harmless the County and its officers and employees from and against all claims, demands, suits, liabilities, damages, losses and expenses resulting from or in any way arising out of the spraying of their driveway pursuant to the terms and conditions of the Calvert County Mosquito Control Program, which causes bodily injury, illness, death or other damage to persons or their property. The consent herein is effective for the 2020 mosquito control season.
