**Item 1**: **Approval of Agenda.**

Town's state mandated amendment to the ethics ordinance at its January 2023 meeting. The Mayor has been formally notified of the approval with a request to move forward with

the amendment to the Ordinance.

**<u>Discussion:</u>** Chairman Feuerle stated the Commission's own amendment proposal was transmitted to

the Mayor and Town Council for comment. To date, no comments have been received.

**<u>Decision:</u>** The Commission, having no objection, moved to have Chairman Feuerle have the Town

Attorney review the amendment proposal before transmitting to the State Ethics

Commission for their review.

Item 5: Review and discussion of the revised disclosure statement.

**<u>Discussion:</u>** Chairman Feuerle stated the Commission was provided with a revised disclosure statement

for review and comments. The Commission discussed suggested revisions.

**Decision:** After discussion, several amendments were unanimously approved. Mr. Feuerle will

prepare a list of "defined terms" to include in the statement, Counsel will provide a list of schedules with descriptions, and the instruction page will be modified to include those. Commissioner Safaie will make formatting adjustments, add page numbers, and make minor modifications as discussed. Once completed, the modified disclosure statement will be circulated to the Commission for review and be discussed at the Commission's next

meeting.
