



Executive Order Regarding the Heroin, Opioid, and Fentanyl Overdose Crisis Declaration of Emergency

- WHEREAS, The State of Maryland is subject to an emergency as defined in Section 14-101(c) of the Public Safety Article of the Code of Maryland;
- WHEREAS, Heroin and opioid abuse is an illness that threatens the wellbeing, productivity, livelihood, and relationships of Marylanders;
- WHERAS, Heroin and opioid use has tripled nationwide in the last 12 months, with approximately 27 million users across the country;

 Supports a Mobilization Period - Facilitate Coordination, Build Information Sharing, Establish and Share Planning Goals and Objectives




